**The Law Offices of Daniel J. Siegel Secures Major Victory for Pharmacies & Physicians
With Dismissal of Insurer's Workers' Compensation Fraud Claims**

December 8, 2021 (Havertown, PA) – The defense in a hotly contested legal battle that started in 2017 scored a major victory after the Pennsylvania Superior Court affirmed the trial court's grant of defendants' motion for summary judgment. The Law Offices of Daniel J. Siegel served as lead defense counsel, successfully representing 31 of the 41 defendants in *Liberty Mutual Group, Inc. et.al. v. 700 Pharmacy, LLC, et. al.*

On November 29, 2021, the appellate court upheld the dismissal of all claims brought by Liberty Mutual Insurance Company, and its various subsidiaries, against over 40 pharmacies, physicians, and other healthcare professionals regarding the prescription of medications for injured workers. In its [decision](#), the Pennsylvania Superior Court ultimately found that the trial court judge correctly dismissed all of the insurers' claims against all of the defendants, whom Liberty Mutual accused of fraud. The Court agreed that Liberty Mutual failed "to present evidence to support their claims of fraud, unjust enrichment, and aiding and abetting."

Daniel J. Siegel, a seasoned trial lawyer, handled the appellate argument and brief, after successfully proving to the trial court that Liberty Mutual presented no evidence to support its claims. "We are pleased with the results, which again show that claims without evidence should be dismissed, no matter who the party is that brings the lawsuit," said Siegel
