
- A. Appellate Practice & Procedure Waiver
 - ☐ *Hassel v. Franzi*, 2019 PA Super 109 (Pa.Super., April 8, 2019)
 - ➤ **Holding:** A party waives an issue on appeal when it does not specifically preserve the issue in the record and does not reproduce on appeal the entire trial record.
- B. Evidence Alcohol Use
 - ☐ Livingston v. Greyhound Lines, Inc., 2019 PA Super 134 (Pa.Super., April 29, 2019)
 - ➤ Holding: A vehicle operator's admission that he was "f..ed up" and had been "smoking pot" are not admissible as evidence because the statements were ambiguous and indefinite about the driver's condition at the time of the accident.
- C. Expert Witness Testimony Qualifications & Disqualification
 - Wright v. Residence Inn by Marriott, Inc., 2019 PA Super 110 (Pa.Super. April 9, 2019)
 - ➤ Holding: An internist is qualified to testify about orthopedic issues in a personal injury matter when his qualifications establish that he possesses a reasonable pretension to specialized knowledge regarding the medical issues sufficient to assist the trier of fact.
- D. Personal Jurisdiction
 - □ Vaughan v. Olympus America, Inc., 2019 PA Super 112 (Pa.Super. April 10, 2019)
 - ➤ Holding: A trial court may exercise personal jurisdiction over an out-of-state defendant that engaged in "relevant acts" together with an in-state company, and is liable for the in-state company's FDA-related conduct in Pennsylvania.
- E. Unemployment Compensation
 - ☐ Harmon v. Unemployment Compensation Board of Review, No. 37 EAP 2017 (Pa. April 26, 2019)
 - ➤ Holding: An unemployment compensation claimant serving a sentence of incarceration on weekends only is not disqualified from receiving unemployment compensation benefits. Chief Justice Saylor, Justice Donohue and Justice Wecht each filed concurring opinions; Justice Mundy filed a dissenting opinion.

 - ☐ *Hammons v. Ethicon Inc.*, No. 458 MAL 2018 (Pa., April 10, 2019)
 - ➤ Whether the Due Process Clause of the Fourteenth Amendment to the United States Constitution and 42. Pa. C.S. § 5322(c) precludes Pennsylvania from asserting personal jurisdiction over two New Jersey companies in a case brought by an Indiana resident asserting claims under the Indiana Product Liability Act?
